

# **2021 Annual Meeting Minutes**

### Attendance:

- 31 participants total
- Board Members present: Ray Bell (president), David Knight (vice president), Austin Aldrich (social chair), Greer Bautz (secretary, swim team liaison), Jeff Martin (membership chair), and Ariel Moyer (treasurer)

## Introduction of board and 2020 recap

- Opened under COVID-19 restrictions with no fee increase to members and flexible membership payment options
- Implemented an online membership management system that was planned pre-COVID 19 but significantly helped us open during COIVD-19 with a reservation system and contact tracing capabilities
- Trimmed costs by eliminating landscaping and only doing what was necessary to open in early July
- Significant 2021 expenses: new water heater, new diving board, dumping of trash on property
- Commitment to tennis program: actively pursued a new board member to help build a more engaging tennis community at Tallyho
- We plan an on-time opening for 2021 (if not early thanks to new water heaters!) and look forward to a new year for members
  - o County and pool operator guidelines are to assume same Covid-19 guidelines

## **Treasurer's Report**

- Review of 2020 spending. The pool had an annual operating deficit of ~\$8k in 2020. This loss was less than anticipated given the impact of COVID on membership and expenses.
- Review 2021 Budget. The proposed 2021 budget reflects the costs associated with a standard season and includes anticipated repair costs for the new heaters, diving board, etc. Revenue projections reflect new dues rates. The 2021 budget was approved unanimously.

#### **Dues 2021 Overview**

- At the 2020 annual meeting the Tallyho Board and membership voted to increase dues;
   then with COVID-19, the Board amended this and voted to keep dues the same as 2019
- Upon review of local area swim and tennis clubs and with the pool's financial goals, the Board proposed a fee increase for 2021 (which was approved unanimously at the meeting)

### **2021** Membership Fees

- <u>Full</u> Membership -- \$685 (bonded)
- Associate Membership -- \$900
- Charter Membership -- \$480
- Empty Nest Membership -- \$470
- Nanny/Resident Guest -- \$75
- Membership will be posted online and open in the early spring

## **Swim Team Update**

- Montgomery County Swim League (MCSL) held its first meeting in early February. There
  is a plan for a 2021 season
- MCSL will provide operating guidelines and waivers from the Montgomery County DHHS
  to run practices and how to structure meets and capacity numbers. We expect this in
  late spring
- Tallyho Board/Swim Team has hired back two senior coaches Akshay Gandhi and Emily Demerest. Assistant Coaches will follow
- Survey will go out in March/April to gauge interest and determine numbers for a team. Parent involvement will be critical to a successful season
- Swim team will not look like 2019, but start sooner and have more structure than the 2020 swim camps

### **Election of the Board**

- NEW Board Member, Shahab Kaviani, Tennis Program Coordinator was approved unanimously.
- Current board members David Knight and Ariel Moyer were renewed unanimously
